Tenderers should have valid PAN card and GST registration and should submit a self-attested copy of the PAN card and GST registration along with the quotation.
- 3. The quantities are approximate and may vary within +/-20% of the quantity mentioned against each item offered for sale.
- 4. Notwithstanding the tender condition No:(3) above, we reserve the right to increase the tendered quantity by +/-20 % when the quantity of scrap material offered is found at a later stage to be more than the tendered quantity, ie, after the tender opening but, certainly before the date of sale order. The successful tenderer shall arrange his own arrangements for collecting and measuring the oil from the existing storage tanks of the company. The scrap oils are only allowed to be shifted during the office hours from 10 A M to 5 P M only.
  - b). The successful tenderer shall arrange the labour for removing the materials from our premises at his cost. The tenderer shall comply with all laws, statute and regulations as may be applicable by virtue of his engaging his own labour for the work within the company premises.
  - c). The successful tenderer shall alone responsible for the safety of all employees and/or workers employed or engaged by him on and in connection with the works and shall forthwith report all cases of accidents to any of them, however caused and whenever occurring, to the Client/Consultant or his representative and shall make every arrangement to render all possible assistance and aid to the victims of the accident.
