S. R. O. No. 496/2017.—In exercise of the powers conferred by section 126 of the Electricity Act, 2003 (Central Act 36 of 2003), the Government of Kerala hereby designate this offices viz. Junior Manager (Technical), Electrical Consultant, Engineer-Project, Senior Manager-Engineering and Assistant Resident Engineer (Electrical) of the suppliers and licencees viz. Kinesco Power Utilities Ltd., Cochin Special Economic Zone Authority, Infopark, Kannan Devan Hill Plantations (P) Ltd. and Rubber Park India (P) Ltd., respectively as the Assessing Officers for the said suppliers and licencees and consequently make the following

Explanatory Note

As per the notification issued under G. O. (P) No. 4/05/PD dated 2nd March, 2005 and published as S. R. O. No. 229/2005 in the Kerala Gazette Extraordinary No. 498 dated 3rd March, 2005, the Government have designated Assessing Officers for the suppliers/licencees mentioned therein.
